We had a portal (www.iehe.ac.in) on our website, through which various responsibilities were assigned to different Heads of the Departments/Committees/Cells staff members on their login_id. All information were collected and disseminated to the concerning stake holders. On IEHE portal, many modules were functioning. They were: (1) Update Profile (2) Profile Report (3) Monthly Attendance Entry (4) Test Marks Entry (5) Assignment Quiz Marks Entry (6) Check All CCE Marks (7) Income Tax Form (8) Income Tax Report (9) Students' Strength (Class wise / Category wise). On the Admin login, various activities were administered. The facilities for	

the admin login were given to (Director, Exam Controller, Finance Controller, Head of Department, Head Clerk, Accountant, Income Tax Committee, Web Admin, Exam Member, UGC Committee, IQAC, etc.) Modules available on Head of the Departments/Committees/Cells login were: (i) Set Paper Title Section (ii) Internal Marks Data for HOD Approval (iii) Generate Honorary Faculty Salary Bill (iv) IQAC Report Form (v) UGC Reports (vi) Reports for Examination, etc. Modules available on Students' login were: (i) Display of CCE details (ii) Admit Card (iii) Statement of Marks (iv) Annual Feedback Form (v) Tutor Guardian Feedback Form. During the session 2018 2019 the Institute developed more modules such as (i) A prototype module for the Internal Evaluation: Conducting Test/Quiz/Survey (ii) Compulsory submission of Annual Feedback Form for students (iii) Tutor Guardian scheme was introduced online for the convenience of parents and students. (iv) Online application form was developed for obtaining transcripts. MP Govt Higher Education Department had centralised online admission process for all government private Colleges of MP. But this Institute was the only one that was exempted from that centralized admission system. It had its own online admission portal which was developed inhouse. Feed Back Report Analysis (a) Alumni Association: 142 pass out students provided written feedback, which concluded: • They appreciated the teaching

pattern Honors based curriculum. • 82 students felt positive change in their personality and are confident enough about their bright future. • 2 students selected in the public sector, 38 in private sectors and 6 students started their own enterprise. • They demanded the need for an auditorium, enriched library improved parking facility. They also focused on transportation facility needed for about 1.5kms from the main road to the Institute. (b) Feedback of Students on Student-Centered Issues under the Tutor-Guardian Scheme: Through the first online survey, conducted on IEHE-portal, the Institute received 1660 feedbacks on the following issues related to: (i) Family (ii) Health (iii) Technology (iv) Social (v) Subject (vi) Career. Analysis: More than 75 students were not facing the above problems. Few percentages were facing intense health social problems - 1, family technological problems - 2, subject problems - 3 career problems - 7. (c) Feedback of Parents on General Issues under the Tutor-Guardian Scheme: 291 parents gave their feedback on general issues as, cleanliness of washrooms, long stay of their ward in the Institute, lack of govt transportation facility, their wards are always busy with academic work at home, infrastructure need to be improved etc. But all the parents were satisfied with teaching methodology the transparency in the evaluation process of examination. (d) Annual Feedback of Students (Mandatory): The annual feedback of the students taken at end of session 2018-19, major views followed: (1) Teaching-Learning Values (in terms of skills, concepts, knowledge, analytical abilities, or broadening perspectives): More than 84 students considered them good and above good. (2) In terms of the "Extent of coverage of course" - 65 students adopted thoroughly. (3) The courses taught in the Institute were appreciated by more than 71 students. (4) More than 75 students were satisfied with the functioning of Library. (5) More than 70 students found student-teacher relationship good and above good. Among the remaining, 21 considered the relationship satisfactory. (6) More than 77 students participated in extracurricular activities of the Department/Institute. Among them about 42 students had active participation. (7) More than 96 students considered the system of Internal Assessment supportive to understand the courses. (8) More than 94 students considered the system of Continuous Comprehensive Evaluation (CCE) supportive to understand their self-assessment. (9) About 90 students considered academic course content received during the session, good above good. (10) More than 92 students considered the activities performed by NCC/NSS unit - good and above good. (11) About 87 students considered the activities of Training Placement cell - good and above good. (12) About 89 students considered the activities of Vocational cell - good and above good. (13) Overall rating of the Institute given by the students: Extremely Good - 17.74, Very Good - 41.47, Moderately Good - 31.52 ... Students Mentoring System Implemented in the Institution (A) Mentoring through Tutor-Guardian (TG) scheme: TG scheme is implemented since inception in the Institute for achieving academic goals and personality development of students. In this session, it was conducted online for the first time. • In the previous sessions, the process of TG was totally in offline mode. The process was conducted in the following manner: The head of all the departments were instructed to allot Tutor Guardian for their students according to the ratio of the teacher-students. In the departments, every TG was given a proforma to get filled by their students and asked them to respond on various dimensions of their students' life. The purpose is to provide them help by identifying their degrees of motives. The teachers were also told to give the list of students in need of counselling. TG

themselves have a proactive role in counselling their wards. In specific cases they motivated students in seeking counselling from the counsellors available in Institute. • TG-Scheme for the session 2018-19: The change was made in the system, making it online to get qualitative data on important dimensions of college going students for their emotional well-being and professional growth development. On the basis of unique feature of the online TGmeet, there was a greater number of students' response as well as from parents' side. Students were suggested to take all types of help from TG as well as counsellors. (i) Feedback of Students on Student-Centric Issues under the Tutor-Guardian Scheme: Through the first online survey, conducted on IEHE-portal, the Institute received 1660 feedbacks on the following issues related to: (i) Family (ii) Health (iii) Technology (iv) Social (v) Subject (vi) Career. Only few students were facing intense health social problems – 1, family-2, technological problems – 2, subject problems – 3 and career problems – 7. (ii) Feedback of Parents on General Issues under the Tutor-Guardian Scheme: 291 parents gave their feedback on general issues such as, cleanliness of washrooms, long stay of their ward in the Institute, lack of govt transportation facility, their wards are always busy with academic work at home, infrastructure need to be improved etc. But all the parents were satisfied with the teaching-learning methodology, transparency in the evaluation process of examination in the Institute. (B) Mentoring under NPTEL Local Chapter: The Institute has its own Local Chapter. The Chapter was established in the month of September, 2017 with ID 1332. In July 2018, our local chapter was graded as "A" and placed at 59th position among 1800 Local Chapters established country-wide. During the session, 07 faculty members were qualified as mentors.

4.4.2 – Procedures and policies for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports complex, computers, classrooms etc. (maximum 500 words) (information to be available in institutional Website)

On the basis of the annual sports calendar of Department of Higher Education, MP Govt, time to time notice is circulated to the students faculty regarding organizing sports in the Institute. The maintenance of instruments and equipment available in sports department through approval of Director on notesheet. The laboratories are used for the practical work according to the timetable of Institute. For smooth functioning and regular maintenance of the apparatus equipment, a technician is working in each laboratory. A fully furnished Central Library with INFLIBNET facility is providing services to the staff students. The process of issue of books to the students is done according to the manual of library. After annual physical verification of the books and other resource materials of the library, a report is submitted to the Director. Old/redundant books are discarded. Torn books are sent for binding. Institute has a fully equipped ICT Cell working under the guidance of Professor incharge. There is an IT In-charge, a Web Administrator a Technical Support Executive working for the regular functioning of the portal (iehe.ac.in), software development, technical assistance and maintenance of all the IT infrastructure. There are SIX smart classes ONE language-lab functional in the

Institute, the maintenance and upkeep of the same is done by ICT cell. All the printers available in the Institute are under Annual Maintenance Contract. Institute has INTERNET through 20 NMEICT VPNoBB FOUR broadband connections of BSNL. The INTERNET facility in the central computer lab, language lab ICT cell is rerouted by the FIREWALL installed in the ICT cell. Policies of Firewall is designed maintained by ICT cell. In Institute's campus Wi-Fi facility in academic blocks is provided maintained by Jio. Monitoring of CCTV cameras is done by ICT cell. Solar panels each of 10KVA are installed in the Central Library Girls hostel. The solar power generated is consumed by the premises itself the care of panels is taken by authorities of library hostel. Solar Water Heater setup is installed in Girls hostel. There are two functional canteens providing service to the staff students. The canteens are run by the outsourced agencies. The cleanliness is maintained by the concerned agency. The quality of the food provided in canteen is checked by the canteen committee of the Institute. Cleaning of the office, class-rooms, toilets, etc. is done by outsourcing agency on regular basis. Guards are deputed from outsourcing for security of Institute's campus. Electrician, Plumber and a Carpenter (who also double up as lab attendants) do the maintenance of their respective area on a regular basis in the Institute. Maintenance of water cooler, RO and sanitary napkin machine is also done on regular basis. Annual physical verification of all the materials (furniture, instruments, etc) available in all the departments and other places in the Institute is done and its report is presented to the Director. Need based repair work is done on the basis of report or as and when required.

FIRST BEST PRACTICE IN MY INSTITUTION 1. Title of the practice: Regular Monthly test of General Knowledge 2. The context that required the initiation of the practice (100-120 words): The institute has been since inception promoting students to appear for competitive exams. To enhance their general knowledge, verbal and non-verbal reasoning these monthly tests are conducted. The students also develop a habit of reading newspaper regularly and are well versed with the happenings around the Global. The students are well prepared to answer on variety of topics and subjects. 3. Objectives of the practice (50-60 words): The various competitive exams are conducted where multiple choice questions are asked. OMR sheet are used to answer these GK tests the students are comfortable answering question in time bound manner. These tests are conducted every month so that the students are prompt and updated in gathering knowledge and skills. Therefore, monthly GK tests are conducted for all students. 4. The Practice (250-300 words): The examinations are from various subjects topics and fifty multiple choice questions are asked. The topics vary from science and technology, verbal, non-verbal reasoning, history, political science, environment and news across the globe. Four sets are made and the seating plan is such that no two adjacent students have same set. 5. Obstacles faced if any and strategies adopted to overcome them (150-200 words): There are three thousand students in our institute. The seating capacity of our rooms is that of one thousand students at a time. Therefore, there are separate test paper made by examination. If there are sufficient i-Pads, i-Spring and other LMS software, online GK tests can be conducted smoothly. Efforts are being made to overcome these obstacles. 6. Impact of the practice (100-120 words): The students of the institute have been selected by various banks, financial institutions, MPPSC, many students have passed UGC-NET with JRF and are well versed with various skills to answer objective type question. The goodwill of the institute increased greatly because of this practice of monthly tests of GK. 7. Resources required: When the examination is to be conducted online in our institute, we would require i-Pads, LMS and i-Spring software for smooth conduct of the examination. 8. Title of the practice: Continuous Comprehensive Evaluation (Internal-Evaluation) 2. The context that required the initiation of the practice (100 -120 words): Since inception the IEHE has initiated the practice of conducting continuous comprehensive examination. The objective of teaching learning is that the student absorbs knowledge, is skilled and attains the right attitude. Therefore the students have to go through regular evaluation and appear for various tests, presentations, practical exams and home assignment. This enhances their grasping of subjects in a better manner. 3. Objectives of the practice (50 - 60 words): The students appear for regular tests, presentation, class room teaching, and group discussion. The nature of evaluation is based on semi-surprise test hence the students are regular in class and are diligent in their studies. Therefore, it is a well thought of Continuous Comprehensive Evaluation plan for internal examination. 4. The Practice (250 - 300 words): The Internal-Examination through Continuous-Comprehensive-Evaluation (CCE) mode and External-Examination (semester end examination) both have equal weightage. This pattern has been followed continuously since inception of the Institute while the UGC has recommended in its evaluation guidelines (Nov 2019) of up to

70 of internal weightage. The continuous comprehensive evaluation which is fifty percent of total marks are on the basis of semi-surprise-written tests, presentations, quizzes, assignments, group-discussion, group-talk, classteaching, poster/chart-making, etc. The curriculum is designed in such a manner that each student selects an honours subject (two papers in each semester) and has a choice of selecting one subsidiary subject (one paper in each semester) during the entire three-year degree course. We conduct regular meetings of Board of Studies (BOS) to update and upgrade the syllabus owing to everchanging scenario. This pattern explores the learning needs of the students as well as the potential of students. It also helps develop cognitive, psychomotor and affective skills. To lay emphasis on thought process and de-emphasize memorization. The CCE helps make the process of teaching and learning a learner centric activity. 5. Obstacles faced if any and strategies adopted to overcome them (150 - 200 words): There are time constraints for conducting various tests and presentation. The internal tests are conducted on monthly basis. A lot of expenditure is incurred on stationery of test papers and answer copies. The marks awarded were entered on paper records. The absentee students would miss various important sessions and test. The strategies to overcome these constraints were well thought of. Extra classes and tutorials were conducted to overcome the time constraints. The tests were shifted to online mode to save paper and stationery. The marks are now entered online by the professors and students have access to check their records. A transparent system has now been designed. 6. Impact of the practice (100 - 120 words): The Continuous Comprehensive Evaluation helps students to group the topics in easily digestible chunks. They become very confident in public speaking, creative writing and comprehension. They are more knowledgeable and have a well rounded personality. The system has created goodwill of the institute. The Internal-Examination through Continuous-Comprehensive-Evaluation (CCE) mode and External-Examination (semester end examination) both have equal weightage. This pattern has been followed continuously since inception of the Institute while the UGC has recommended in its evaluation guidelines (Nov 2019) of up to 70 of internal weightage. The continuous comprehensive evaluation which is fifty percent of total marks are on the basis of semi-surprise-written tests, presentations, quizzes, assignments, group-discussion, group-talk, class-teaching, poster/chart-making, etc. The curriculum is designed in such a manner that each student selects an honours subject (two papers in each semester) and has a choice of selecting one subsidiary subject (one paper in each semester) during

hence GK tests are conducted on a monthly basis in each semester. Marks of these tests are converted on percentile basis and appropriate weightage is added in the internals of Foundation Course. Separate Vocational-Cell is functioning in the Institute. The Vocational-Cell conducts various diploma and certificate courses for the benefit of students. These courses are evaluated on the basis of grading system. Subject-experts from the Industry Academia are invited to deliver lecture and impart practical first-hand knowledge. On job training, field-visits, simulation, hands-on practice are the regular features of these courses. Other than our Institute's students, outside students are also allowed to attend these courses. Placement cell plays an important role in conducting campus recruitment drive. District level career-fair is also organized every year in the Institute and a lot of companies participate in it. Online placement functionality (Student's Registration for Placement, Placement Statistics, etc) were introduced in the current session. Orientation lectures Skill Enhancement trainings were organized by the placement cell of the Institute. Invited subject-experts interacted with the students to prepare them for competitive examinations. Training was conducted on various topics round the year, to name a few - Fashion Illustration, Tie Dye, Block Printing, Food Quality Safety, etc. Lectures workshops were also conducted on various topics, like - Career options after graduation, Mutual funds, Personality Development, Motivational lecture on preparation for competitive examinations, Workshop on "Short tricks to crack competitive exams", Mock Aptitude Test, etc. Institute conduct its own admission process through the iehe-portal (iehe.ac.in). Total transparency is maintained in the admission process. Other higher education institutes of M.P. Govt. have a common admission portal while IEHE is distinct in its special status of admission. NCC wing of the Institute also has the distinct achievement of participating in RDC New Delhi, and a cadet was selected for DGNCC Commendation Card.
