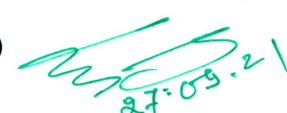
- To engage in dialogue with the government agencies and municipal corporation in the areas of environment, energy efficiency, social awareness and sustainable development.
