Report on National Webinar of Professional - Students Summit 2020 on "Easy Accounting Practices"

The Webinar was organized under the **Initiative for Academic Excellence by Madhya Pradesh Higher Education Quality Improvement Project**(MPHEQIP)

On **19th March 2021** at 12:00 clock on the **Microsoft Teams App,** the Summit session was live. The session started with his introduction first.

CA Anaadi Mishra, a Qualified Chartered Accountant and having cleared his CS Exams, has 5 years of teaching experience in several Institutes and universities across Bhopal, MP. He is a practicing CA with MAARG & Associates. Awarded the merit rank in BSSS College for M.Com, he has cleared his Junior Research Fellowship and UGC NET thrice along with MP SLET Exam. He also holds a B.A. (Visharad) in Tabla from the Khairagarh University in Chhattis garh and has performed on Piano both nationally and internationally.
